CALL FOR ENTRIES- HENNY PENNY EXHIBIT

The PCAA and Henny Penny are partnering to show off the regions talent to Henny Penny executives, clients and staff. Artists have the opportunity to exhibit their work inside of the Henny Penny Corporate office in Eaton, Ohio. This is a year long exhibit in which artists will be compensated.

ELIGIBILITY

MEDIUMS

Entries will be accepted in any medium but **MUST** be wired to hang on the wall. A variety of mediums are encouraged. No saw tooth hangers or cleats accepted.

PRESENTATION

Works must be presentable, completely finished and ready to exhibit. All work must be finished, framed and/or matted as appropriate.

SIZE

Work must fit through a standard size door. The PCAA staff has the right to reject any work not properly prepared for display. This exhibition is open to all artists. Work must be available for the entire exhibit. This is a JURIED exhibit and all works will be juried in. Not all submissions will be accepted. Due to the size of the exhibit space, preference will be given to works that are 24" or larger.

INSURANCE AND LIABILITY

Preble County Art Association is not responsible for any damages done to work due to craftsmanship or artist's negligence. Framing must be secure. Works not for sale must have an insurance value. All claims must be backed by proof of sale. There is no disaster insurance provided.

COMMISSION

Works exhibited can be for sale and Henny Penny encourages their staff to make purchases. A 30% commission will be taken from each sale.

Entries and Drop off

IN PERSON ENTRY PROCESS

In person drop offs are on Thursday, August 24th and Friday, August 25th 11am-6pm. An entry form should accompany entries. All work must be available for the entire exhibit.

UNACCEPTED ENTRIES

Due to space limitations, not all work will be accepted for display. Works not chosen for exhibit may be picked up Thursday, August 31 and Friday, September 1, 11am-6pm. A PCAA representative will notify you of your acceptance status via email by midnight on August 30.

END OF EXHIBIT PICK UP

Exhibited works will be taken down by September of 2018. The PCAA will notify you of pick up procedures.

COMPENSATION

All artists exhibiting work will be given a rental fee for their artwork at a minimum of \$50 and not to exceed 10% of the value of the artwork. The PCAA will determine the rental fee amount.
